Chair Kaplan called the meeting to order at 8:05 AM.

Meeting Minutes: Mr. Lyon moved to approve the minutes of November 14, 2005. Second Chair Kaplan and approved 2-0.

HB 653: Ms. Levine brought the Selectmen up-to-date on HB 653, which amends state law to allow municipalities to bond for the purpose of installing broadband infrastructure. Ms. Levine also updated the Selectmen on her involvement with a regional consortium of towns discussing telecommunications infrastructure, pole space, funding opportunities, etc. This led to a discussion of franchise agreements, cable infrastructure, and cost.

Kearsarge Regional Middle School: Ms. Lavoie asked if a meeting was still scheduled for November 28 among the towns and the School Board. Ms. Levine said that it had been cancelled based on conversations with the School Board and the possibility that there will be two warrant articles.
