**APPROVED Minutes of the December 29, 2010 Special Conservation Commission Meeting**  
**MEMBERS PRESENT: Bob Brown (Chairman), Sue Clough, Emma Crane, Dan Allen, Terry Dancy (Alternate filling in for Vicki Koron), Andy Deegan, Laura Alexander**  
**MEMBERS ABSENT: Vicki Koron**  
**OTHERS PRESENT: Bob Crane (Webmaster), Peter Stanley (Planning and Zoning Administrator/Staff)**

Chair Brown called the meeting to order at 1:00pm and asked Peter Stanley to explain the purpose of the meeting.

Peter Stanley explained that when the 2 acre field/log landing was constructed at the Phillips Preserve in the fall of 2007, the project ran out of money before the last dozen or so loads of stumps and post logging debris (already pulled and piled) could be trucked away, and the area brought to final grade. He went on to explain that a thinning and limited harvest was done in 2007 in order to improve the timber stand and raise the funds necessary to upgrade the access road and create the field/log landing, as proposed by the Phillips Preserve Forest Management Plan. Gallup Trucking, the excavation contractor that did the work in 2007, estimated up to \$2000 to do the final cleanup and grading and has provided a contract to that effect.

**IT WAS MOVED (Andy Deegan) AND SECONDED (Laura Alexander) to proceed with the final phase of the Phillips Preserve project.**

**Discussion:** Sue Clough expressed her support for the project, explaining that she had visited the site after the timber harvest and approved of the work that had been done to date. She supports the expenditure to complete the project.

There were comments of support from those that had visited the site, including Andy Deegan, Terry Dancy and Bob Brown.

Bob Brown went on to explain that there was more than enough money in the 2010 budget to do the work.

**THE MOTION WAS APPROVED UNANIMOUSLY.**

**IT WAS MOVED (Dan Allen) AND SECONDED (Andy Deegan) to Adjourn the meeting.**
