**3. Discussion of Master Plan Process:**

Discussion regarding the survey included comments that the 2011 Master Plan Survey was too long, but that there was valuable information to be taken from it and built upon for our next survey. It was suggested that the committee use the Wilmot survey as a template while inserting specific pieces of the 2011 survey that should be included. Jeremy Bonin volunteered to merge the New London and Wilmot surveys to use as a redline document.

The group discussed what to include on the survey regarding accessory dwelling units (ADU). It was mentioned that the previous Master Plan supported ADUs, we should gauge whether that is still the sentiment of the town.

While discussing the focus groups that would be conducted to reach specific interest groups, it was suggested that the groups be divided into subgroups to include:

1. Institutions
2. Homeowner's Associations
3. Chamber of Commerce and other businesses
4. Lake Protective Associations

The groups should be help to 15-20 people at most. Jeremy volunteered to look further at the group list to divide into sub-groups.

AT the next meeting we will discuss the sub groups, identify contacts for each group and develop a list of questions.
